



Application for the Obesity Treatment Proficiency Badge in Medication Management

To earn a proficiency badge in medication management, you must complete the 20 courses of core content. The core content only needs to be completed once. To apply for the medication management proficiency badge, you will need to complete 5 courses of the specialized content. Courses can be completed through live event attendance or through recorded lectures. A list of OMA courses that count towards the badge can be found on the OMA website, [core content](#) and [medication specialized content](#).

Once all the 25 required courses are completed, fill out this application and pay the badge application fee of \$100. Complete each section, on the second page, with the session title, date completed, and check off whether the course was completed live or recorded. Please allow up to 4 weeks for your application to be reviewed. If all the requirements are met, you will be issued your badge.
